##### **Work Session**

HB 4061 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs the Oregon Business Development Department to collaborate with the Port of Portland, the Oregon Tourism Commission, the State Department of Agriculture and other stakeholders on updating the unified trade strategy for Oregon.

##### **Public Hearing and Work Session**

HB 4086 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs the Oregon Business Development Department to develop a roadmap for the purpose of promoting industrial symbiosis activities in Oregon.

##### **Work Session**

HB 4104 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Authorizes Oregon CHIPS Fund grants and loans to businesses that are eligible for federal semiconductor financial assistance under the CHIPS Act but have not applied for it.  
HB 4139 \*\* \*\*Subsequent Referral(s) to Revenue then to Ways and Means  
Defines "container" and "industrial hemp-derived cannabinoid product."
