HB 4022

Establishes the Oregon Imagination Library Program to provide a free book each month to eligible children, encourage children to develop a love of reading and learning and improve school readiness, third-grade reading proficiency and high school graduation rates.

HB 4058

Permits the Department of Human Services to place an Indian child in an out-of-state placement without requiring the placement to be licensed by or under contract with the department or to be a qualified residential treatment facility if certain standards are met.

HB 4057

Directs the Department of Early Learning and Care to provide standardized information on all publicly funded early learning and care programs and resources available in this state to people who apply for the Employment Related Day Care subsidy program.
