Work Session

SB 1537 A

Requires the members of a board of education of a community college district to have an official electronic mail address that is posted on a publicly accessible website.

SB 1538 A

Requires district school boards to admit all students to all schools and instructional programs of the school district.

SB 1596 A

Directs the State Board of Education to allow play-based learning to be considered instructional time for students in kindergarten through grade five.
