Work Session

- HB 4047 ** **Subsequent Referral(s) to Ways and Means
Requires the Oregon Health Authority to adopt rules and procedures to allow a hospital to apply for a license as a rural emergency hospital.
- HB 4048 ** **Subsequent Referral(s) to Revenue
Expands the rural health care income tax credit to include pharmacist services performed in rural communities.
- HB 4053 ** **Subsequent Referral(s) to Ways and Means
Establishes the Emergency Medical Services Program Fund.
- HB 4074
Directs a hospital to implement a hospital-wide nurse staffing plan that has been developed and adopted by the hospital nurse staffing committee or, if the committee has not adopted a plan, a hospital-wide nurse staffing plan that meets the statutory requirements.
- HB 4075
Authorizes the State Treasurer to loan up to 20 percent of the Unclaimed Property and Estates Fund to rural hospitals for financial stabilization.
- HB 4107
Requires an urgent care center to make publicly available specified information about the urgent care center, offer specified services and, except in certain circumstances, have at least one licensed health care provider on site during the hours of operation.
- HB 4131
Directs the State Board of Pharmacy to issue a license to operate a mobile pharmacy to a qualified applicant.
- HB 4142
Expands the definition of "debilitating medical condition" for the medical use of marijuana.
- HB 4155 ** **Subsequent Referral(s) to Ways and Means
Requires certain health insurers, the Oregon Educators Benefit Board and the Public Employees' Benefit Board to cover fertility services and treatments.

- HB 4156 ** **Subsequent Referral(s) to Ways and Means
Modifies the requirements for Medicaid supplemental reimbursements paid to emergency medical services providers.
- HB 4003
Removes provisions relating to the use of the prioritized list of health services in the state medical assistance program.
- HB 4040
Modifies the requirements for screening a hospital patient for presumptive eligibility for financial assistance.
- HB 4127
CARRIED OVER FROM THE 02/10/2026 MEETING: Requires the Oregon Health Authority to adopt a payment mechanism to pay certain nonprofit reproductive health care providers that are not eligible to receive federal Medicaid funds for services provided to medical assistance recipients.
