Public Hearing and Possible Work Session

HB 4120

Allows residential landlords of multifamily housing to convert premises to nonsmoking for existing tenants upon 90 days' written notice.

Possible Work Session

HB 4064

Establishes when homeowners and condominium association assessments accrue on property deeded to the county in the tax foreclosure process.

HB 4113

Requires the Department of Land Conservation and Development to study housing development opportunities conditioned upon land conservation.

HB 4128

Prohibits covered entities from purchasing, acquiring or offering to purchase or acquire a single-family residence unless the residence has been listed for sale to the general public for at least 90 days.
