Public Hearing

HB 4012

Requires the Bureau of Labor and Industries to study the adequacy of the statutory provisions governing labor contractors.

HB 4013

Clarifies which federal rules apply to the scope of the rulemaking authority of the Bureau of Labor and Industries regarding rules that govern the hours a minor can work.

HB 4027

Requires the Legislative Policy and Research Director to conduct a study of the manner in which state labor agencies in other states are funded.

HB 4093

Directs the Bureau of Labor and Industries to create certain guidance and informational materials to assist employers and employees.
