Authorizes the Director of the Employment Department to adopt rules establishing an accounting system for handling moneys in the Paid Family and Medical Leave Insurance Fund.

CARRIED OVER FROM THE 2/11/2026 MEETING: Expands the requirement to discuss class size and caseload as mandatory subjects of bargaining for purposes of school district collective bargaining.

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 2/11/2026 MEETING: Requires the Legislative Policy and Research Director to conduct a study of the manner in which state labor agencies in other states are funded.

HB 4089

CARRIED OVER FROM THE 2/11/2026 MEETING: Specifically includes in the crime of theft of services the nonpayment of compensation of employees and independent contractors.

HB 4094

CARRIED OVER FROM THE 2/11/2026 MEETING: Requires employers who provide paid vacation time to compensate employees for all earned or accrued but unused paid vacation time when employment terminates.
