SB 1525 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes the Blue Economy Task Force.

SB 1526

Requires the State Department of Energy to apply for grant moneys from the State Agency Program Fund to cover the costs and expenses of carrying out pre-startup activities and forming a nonprofit entity.

SB 1597

Requires an electric utility to disclose to its customers the costs of storing the waste produced by an energy facility in generating electricity.
