#### Public Hearing and Possible Work Session

SB 1590  
Prohibits public bodies from assisting the federal government with privatization of certain federally owned lands.

#### Public Hearing

SB 1539  
Allows an individual to verify whether cattle are pregnant without holding a valid license issued by the Oregon State Veterinary Medical Examining Board under certain circumstances.

#### Public Hearing and Possible Work Session

SB 1551  
Invalidates deed restrictions and planned community governing documents prohibiting the removal of nonfire-hardened building materials or installation of fire-hardened building materials on residential properties.

#### Public Hearing

SB 1584 \*\*  
Directs the Department of State Lands, in consultation with the State Department of Fish and Wildlife, to develop a salmon credit pilot program to encourage the voluntary restoration of salmonid habitat in the Coquille and Coos watershed basins.
