The number of bills introduced in the Oregon legislature has increased in the last two long sessions, with the 2025 session being a record high. At the same time, a lower percentage of bills have passed.

# HB 4002 -4 Amendment

<b>Individual Legislator</b>	<ul style="list-style-type: none"><li>• <b>30</b> draft requests</li><li>• Deletes the "one-out, one-in" provision from HB 2006 (2025)</li></ul>
<b>Legislative Committees</b>	<ul style="list-style-type: none"><li>• <b>10</b> draft requests. Plus an additional <b>5</b> drafts if requested by the committee chair <b>and</b> a member of the minority party who is a member of the committee</li><li>• House/Senate Revenue may request an additional <b>15</b> drafts for HBs/SBs</li><li>• Joint Ways and Means exempt</li></ul>
<b>Additional Requests</b>	<ul style="list-style-type: none"><li>• House Committee on Rules may request an additional:<ul style="list-style-type: none"><li>• <b>15</b> drafts for HBs/HJRs</li><li>• <b>20</b> drafts for HRs or HJRs</li></ul></li><li>• Senate President may request an additional:<ul style="list-style-type: none"><li>• <b>15</b> drafts for SBs/SJRs</li><li>• <b>20</b> drafts for SRs or SJRs</li></ul></li></ul>
<b>Governor and State Agencies</b>	<ul style="list-style-type: none"><li>• <b>100</b> draft requests</li><li>• Excludes DAS budget implementation measures</li></ul>
<b>Statewide Electeds, Oregon Judicial Dept.</b>	<ul style="list-style-type: none"><li>• <b>10</b> draft requests/entity</li></ul>
