Summary of Revenue Changes

House Bill 4086 appropriates \$1,150,000 General Fund to the Oregon Business Development Department (OBDD) to develop an industrial symbiosis roadmap and provide technical assistance grants to pilot communities identified in the bill.

Summary of Transportation and Economic Development Subcommittee Action

House Bill 4086 defines industrial symbiosis as voluntary collaboration and resource sharing among businesses or other organizations. The measure directs OBDD to develop a plan (referred to as the “Industrial Symbiosis Roadmap”) to promote and encourage voluntary industrial symbiosis activities in Oregon. The measure also directs OBDD to provide a report on the plan to the Legislature by May 1, 2027.

The Subcommittee recommended a total of \$1,150,000 General Fund. Of this amount, \$900,000 will fund technical assistance grants to four designated entities for planning and development of industrial symbiosis projects, and \$250,000 for OBDD to hire a contractor to assist in developing the Industrial Symbiosis Roadmap required by the bill.
