### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act says that it is the policy of this state to make sure people are allowed to get certain kinds of health care, including care for their bodies and gender identity. The Act also makes changes to laws about helping the federal government and other states in cases arising involving this kind of care, makes some records and information private and says that midwives who give this kind of care will not get in trouble if they follow the rules. The new law starts right away. (Flesch Readability Score: 60.7).

Declares this state's policy to protect engagement in certain activities relating to reproductive health care and gender-affirming treatment.

Prohibits cooperation with law enforcement agencies of the federal government or other states in actions involving legally-protected reproductive or gender-affirming health care activities.

Modifies provisions regarding interstate actions involving legally-protected reproductive or gender-affirming health care activities.

Makes specified records and information confidential.

Provides protection from disciplinary action for direct entry midwives who provide reproductive health care and gender-affirming treatment under specified circumstances.

Declares an emergency, effective on passage.

4 **Be It Enacted by the People of the State of Oregon:**

### INTERSTATE ACTIONS

7 **SECTION 1. Policy regarding legal protections for reproductive or gender-affirming**  
8 **health care activities.** (1) "Gender-affirming treatment" and "reproductive health care" have  
9 the meanings given those terms in ORS 24.500.

10  
11 **(2) It is the policy of this state that people should be protected under state law to engage**  
12 **in the following activities related to reproductive health care or gender-affirming treatment**  
13 **that is provided by a health care provider who is licensed in this state, who is acting within**  
14 **the health care provider's scope of practice and who provides or attempts to provide the**  
15 **reproductive health care or gender-affirming treatment to a patient who is physically located**  
16 **in this state:**

17 **(a) The receipt or attempted receipt of reproductive health care or gender-affirming**

1 treatment that is lawful in this state.

2 (b) The provision or attempted provision of reproductive health care or gender-affirming  
3 treatment that is lawful in this state.

4 (c) The assistance or attempted assistance in the receipt or provision of reproductive  
5 health care or gender-affirming treatment that is lawful in this state.

6 **SECTION 2. Nonfugitive extradition.** (1) As used in this section, “legally-protected re-  
7 productive or gender-affirming health care activities” means one or more of the activities  
8 described in section 1 of this 2026 Act.

9 (2) Except as required by federal law and notwithstanding ORS 133.767, the Governor of  
10 this state may not surrender, on demand of the executive authority of any other state, a  
11 person in this state charged in such other state for engaging in legally-protected reproduc-  
12 tive or gender-affirming health care activities if the Governor is not otherwise required to  
13 surrender the person under ORS 133.747.

14 **SECTION 3. Cooperation with federal and interstate investigations.** (1) As used in this  
15 section:

16 (a) “Legally-protected reproductive or gender-affirming health care activities” means one  
17 or more of the activities described in section 1 of this 2026 Act.

18 (b) “Public body” means a public body as defined in ORS 174.109 and the Oregon Health  
19 and Science University.

20 (2)(a) Except as provided in ORS 24.500 and 133.747, or as required by federal law, an of-  
21 ficer, employee or agent of a public body may not cooperate with, provide information to or  
22 otherwise expend or use time, moneys, facilities, property, equipment, personnel or other  
23 resources to assist a federal law enforcement agency, a law enforcement agency of another  
24 state, a private citizen or a quasi-law enforcement agent in relation to an investigation or  
25 inquiry into a legally-protected reproductive or gender-affirming health care activity, if such  
26 activity would be lawful if it occurred entirely in this state.

27 (b) Nothing in this subsection prohibits an officer, employee or agent of a public body  
28 from disclosing information that is responsive to an investigation or inquiry described in  
29 paragraph (a) of this subsection to the extent the information is available to the general  
30 public provided the disclosure is made under the same terms and conditions as the informa-  
31 tion is made available to the general public.

32 **SECTION 4.** ORS 15.430 is amended to read:

33 15.430. Notwithstanding ORS 15.440, 15.445 and 15.455, Oregon law governs noncontractual  
34 claims in the following actions:

35 (1) Actions in which, after the events giving rise to the dispute, the parties agree to the appli-  
36 cation of Oregon law.

37 (2) Actions in which none of the parties raises the issue of applicability of foreign law.

38 (3) Actions in which the party or parties who rely on foreign law fail to assist the court in es-  
39 tablishing the relevant provisions of foreign law after being requested by the court to do so.

40 (4) Actions filed against a public body of the State of Oregon, unless the application of Oregon  
41 law is waived by a person authorized by Oregon law to make the waiver on behalf of the public  
42 body.

43 (5) Actions against an owner, lessor or possessor of land, buildings or other real property situ-  
44 ated in Oregon that seek to recover for, or to prevent, injury on that property and arising out of  
45 conduct that occurs in Oregon.

1       (6) Actions between an employer and an employee who is primarily employed in Oregon that  
2 arise out of an injury that occurs in Oregon.

3       (7) Actions for professional malpractice arising from services rendered entirely in Oregon by  
4 personnel licensed to perform those services under Oregon law.

5       (8)(a) Actions against a provider of reproductive health care or gender-affirming treatment[, as  
6 those terms are defined in ORS 24.500,] if the reproductive health care or gender-affirming treatment  
7 at issue was provided **or attempted to be provided** in this state.

8       (b) Actions against a patient receiving **or attempting to receive** reproductive health care or  
9 gender-affirming treatment if the reproductive health care or gender-affirming treatment at issue  
10 was [received] **provided or attempted to be provided** in this state.

11       (c) Actions against any person who provides **or attempts to provide** aid, assistance,  
12 resources, **encouragement** or support to a person in providing or receiving **or attempting to**  
13 **provide or receive** reproductive health care or gender-affirming treatment **provided** in this state.

14       (d) **For purposes of this subsection, reproductive health care or gender-affirming treat-  
15 ment is provided in the state in which the patient is physically located at the time the ser-  
16 vices are provided.**

17       (e) **As used in this subsection, “reproductive health care” and “gender-affirming treat-  
18 ment” have the meanings given those terms in ORS 24.500.**

19       SECTION 5. ORS 24.500 is amended to read:

20       24.500. (1) As used in this section:

21       (a) “Gender-affirming treatment” means a procedure, service, drug, device or product that a  
22 physical or behavioral health care provider prescribes to treat an individual for incongruence be-  
23 tween the individual’s gender identity and the individual’s sex assignment at birth.

24       (b) “Reproductive health” means reproductive processes, functions and systems at all stages of  
25 life.

26       (c) “Reproductive health care” includes family planning and contraception, pregnancy termi-  
27 nation services, prenatal, postnatal and delivery care, miscarriage management, fertility care,  
28 sterilization services, treatments for sexually transmitted infections and reproductive cancers and  
29 any other health care and medical services related to reproductive health.

30       (2) A law of another state that authorizes a person to bring a civil or criminal action against  
31 [a person that] **another person who** does any of the following is contrary to the public policy of this  
32 state:

33       (a) [Receive] **Receives or attempts to receive** reproductive health care or gender-affirming  
34 treatment;

35       (b) [Provide or attempt] **Provides or attempts** to provide reproductive health care or gender-  
36 affirming treatment; or

37       (c) Knowingly [engage in conduct that aids or abets] **engages in conduct that aids or encour-  
38 ages or attempts to aid or encourage** the provision of reproductive health care or gender-  
39 affirming treatment.

40       (3) Notwithstanding ORCP 38 C, a person may not request that a clerk of court issue a subpoena  
41 for service upon a person to whom a foreign subpoena is directed if the foreign subpoena relates to  
42 gender-affirming treatment or reproductive health care services that are permitted under the laws  
43 of this state, unless the person requesting the subpoena provides a written declaration that the  
44 foreign subpoena relates to:

45       (a) An out-of-state action founded in tort, contract or statute, for which a similar claim would

1 exist under the laws of this state, brought by a patient or the patient's authorized legal representative,  
2 for damages suffered by the patient; or

3 (b) An out-of-state action founded in contract, and for which a similar claim would exist under  
4 the laws of this state, brought or sought to be enforced by a party with a contractual relationship  
5 with the person that is the subject of the subpoena.

### 8 (Individually Identifiable Information)

10 **SECTION 6. Section 7 of this 2026 Act is added to and made a part of ORS 40.225 to 40.295.**

11 **SECTION 7. Privilege regarding reproductive or gender-affirming health care.** (1) As used  
12 in this section:

13 (a) "Individually identifiable information" has the meaning given that term in section 9  
14 of this 2026 Act.

15 (b) "Proceeding" means a judicial or administrative proceeding, other than a proceeding  
16 directly related to the Oregon Health Authority's administration of the state medical as-  
17 sistance program or the programs described in ORS 435.230.

18 (2)(a) The authority or an agent or employee of the authority may not be examined in a  
19 proceeding as to the individually identifiable information of an individual that is acquired by  
20 the authority in the course of carrying out its duties and responsibilities in administering  
21 the state medical assistance program or the programs described in ORS 435.230.

22 (b) This section does not apply if the individual consents to the examination described in  
23 paragraph (a) of this subsection.

24 **SECTION 8. Section 9 of this 2026 Act is added to and made a part of ORS 435.190 to**  
25 **435.245.**

26 **SECTION 9. Confidentiality of individually identifiable information.** (1) As used in this  
27 section, "individually identifiable information" means any health information in any form or  
28 medium that is identifiable to an individual, including demographic information that identi-  
29 fies the individual, or for which there is a reasonable basis to believe the information can  
30 be used to identify an individual, and that relates to applications for or receipt of legally-  
31 protected reproductive or gender-affirming health care activities.

32 (2) Except to the extent an individual consents to the information's disclosure, the  
33 individual's individually identifiable information obtained by the authority:

34 (a) Is confidential and not subject to disclosure under ORS 192.311 to 192.478;

35 (b) May be disclosed only as necessary and directly connected with the administration  
36 of the state medical assistance program or the authority's duties and responsibilities under  
37 ORS 435.230; and

38 (c) Is confidential, nondiscoverable and inadmissible in any judicial or administrative  
39 proceeding that is not directly connected with the authority's administration of the state  
40 medical assistance program or the programs described in ORS 435.230.

41 **SECTION 10. ORS 435.190 is amended to read:**

42 435.190. As used in ORS 435.190 to 435.245:

43 (1) "Contraception" includes:

44 (a) Steroidal, chemical, physical or barrier, natural or permanent methods for preventing the  
45 union of an ovum with the spermatozoon, or for preventing the subsequent implantation of the fer-

- 1       tilized ovum in the uterus;
- 2       (b) All postcoital methods, drugs or devices to prevent pregnancy; and
- 3       (c) Any other process, device or method to prevent pregnancy.

(2) "Legally-protected reproductive or gender-affirming health care activities" means one or more of the activities described in section 1 of this 2026 Act.

[2] (3) "Public body" means a public body as defined in ORS 174.109 and the Oregon Health and Science University.

[3)] (4) "Reproductive health" means reproductive processes, functions and systems at all stages of life.

10        [(4)] (5) "Reproductive health care" includes family planning and contraception, pregnancy ter-  
11 mination services, prenatal, postnatal and delivery care, miscarriage management, fertility care,

**(Court Records)**

17 **SECTION 11.** ORS 33.420 is amended to read:

33.420. (1) Except as provided in ORS 109.360, before entering a judgment for a change of name  
in the case of a minor child, the court shall require that written notice **of the application for the**  
**change of name of the minor child** be given to the parents of the child, both custodial and non-  
custodial, and to any legal guardian of the child.

22 (2) Notwithstanding subsection (1) of this section, notice of an application for the change of  
23 name of a minor child does not need to be given to a parent of the child if the other parent of the  
24 child files a verified statement in the change of name proceeding that asserts that the minor child  
25 has not resided with the other parent and that the other parent has not contributed or has not tried  
26 to contribute to the support of the child.

27 (3)(a) In a case to determine an application for change of name of a person under ORS 33.410,  
28 if an applicant who is a certified adult program participant in the Address Confidentiality Program

33.460. (1) Application for legal change of sex of a person may be heard and determined by any  
34 circuit court in this state. A circuit court may order a legal change of sex and enter a judgment  
35 indicating the change of sex if the individual attests that the individual has undergone surgical,  
36 hormonal or other treatment appropriate for the individual for the purpose of affirming gender  
37 identity.

42 (2) The court may order a legal change of sex and enter the judgment in the same manner as  
43 that provided for change of name of a person under ORS 33.410.

44 (3) Application for simultaneous change of name and legal change of sex may be heard and de-  
45 termined by any circuit court in this state. If a person applies for a change of name under ORS

1 33.410 at the time the person applies for a legal change of sex under this section, the court may  
2 order change of name and legal change of sex at the same time and in the same proceeding.

3 **(4)(a) Except as provided in paragraph (b) of this subsection, a case to determine an ap-  
4 plication for legal change of sex, including an application for simultaneous change of name  
5 and legal change of sex, is confidential, exempt from public disclosure under ORS 192.311 to  
6 192.478 and may not be disclosed except:**

7 **(A) To a party in the case or the party's attorney;**  
8 **(B) To the court;**  
9 **(C) Pursuant to a court order for good cause shown, and subject to the provisions of ORS  
10 192.324; or**

11 **(D) As required by the court to comply with the notice requirement under ORS 33.420.**

12 **(b) An applicant may move the court to make the case public or to make the register  
13 and certain records in the case public.**

14 **(c) The court, upon the motion of the applicant, shall make confidential a case described  
15 in this subsection or a register and certain records in the case described in this subsection,  
16 if the case or register and records are not already confidential.**

18 **(Public Records Exemptions)**

19

20 **SECTION 13.** ORS 192.345 is amended to read:

21 192.345. The following public records are exempt from disclosure under ORS 192.311 to 192.478  
22 unless the public interest requires disclosure in the particular instance:

23 (1) Records of a public body pertaining to litigation to which the public body is a party if the  
24 complaint has been filed, or if the complaint has not been filed, if the public body shows that such  
25 litigation is reasonably likely to occur. This exemption does not apply to litigation which has been  
26 concluded, and nothing in this subsection shall limit any right or opportunity granted by discovery  
27 or deposition statutes to a party to litigation or potential litigation.

28 (2) Trade secrets. "Trade secrets," as used in this section, may include, but are not limited to,  
29 any formula, plan, pattern, process, tool, mechanism, compound, procedure, production data, or  
30 compilation of information which is not patented, which is known only to certain individuals within  
31 an organization and which is used in a business it conducts, having actual or potential commercial  
32 value, and which gives its user an opportunity to obtain a business advantage over competitors who  
33 do not know or use it.

34 (3) Investigatory information compiled for criminal law purposes. The record of an arrest or the  
35 report of a crime shall be disclosed unless and only for so long as there is a clear need to delay  
36 disclosure in the course of a specific investigation, including the need to protect the complaining  
37 party or the victim. Nothing in this subsection shall limit any right constitutionally guaranteed, or  
38 granted by statute, to disclosure or discovery in criminal cases. For purposes of this subsection, the  
39 record of an arrest or the report of a crime includes, but is not limited to:

40 (a) The arrested person's name, age, residence, employment, marital status and similar bi-  
41 ographical information;  
42 (b) The offense with which the arrested person is charged;  
43 (c) The conditions of release pursuant to ORS 135.230 to 135.290;  
44 (d) The identity of and biographical information concerning both complaining party and victim;  
45 (e) The identity of the investigating and arresting agency and the length of the investigation;

1       (f) The circumstances of arrest, including time, place, resistance, pursuit and weapons used; and  
2       (g) Such information as may be necessary to enlist public assistance in apprehending fugitives  
3 from justice.

4       (4) Test questions, scoring keys, and other data used to administer a licensing examination,  
5 employment, academic or other examination or testing procedure before the examination is given  
6 and if the examination is to be used again. Records establishing procedures for and instructing  
7 persons administering, grading or evaluating an examination or testing procedure are included in  
8 this exemption, to the extent that disclosure would create a risk that the result might be affected.

9       (5) Information consisting of production records, sale or purchase records or catch records, or  
10 similar business records of a private concern or enterprise, required by law to be submitted to or  
11 inspected by a governmental body to allow it to determine fees or assessments payable or to estab-  
12 lish production quotas, and the amounts of such fees or assessments payable or paid, to the extent  
13 that such information is in a form that would permit identification of the individual concern or en-  
14 terprise. This exemption does not include records submitted by long term care facilities as defined  
15 in ORS 442.015 to the state for purposes of reimbursement of expenses or determining fees for pa-  
16 tient care. Nothing in this subsection shall limit the use that can be made of such information for  
17 regulatory purposes or its admissibility in any enforcement proceeding.

18       (6) Information relating to the appraisal of real estate prior to its acquisition.

19       (7) The names and signatures of employees who sign authorization cards or petitions for the  
20 purpose of requesting representation or decertification elections.

21       (8) Investigatory information relating to any complaint filed under ORS 659A.820 or 659A.825,  
22 until such time as the complaint is resolved under ORS 659A.835, or a final order is issued under  
23 ORS 659A.850.

24       (9) Investigatory information relating to any complaint or charge filed under ORS 243.676 and  
25 663.180.

26       (10) Records, reports and other information received or compiled by the Director of the De-  
27 partment of Consumer and Business Services under ORS 697.732.

28       (11) Information concerning the location of archaeological sites or objects as those terms are  
29 defined in ORS 358.905, except if the governing body of an Indian tribe requests the information and  
30 the need for the information is related to that Indian tribe's cultural or religious activities. This  
31 exemption does not include information relating to a site that is all or part of an existing, commonly  
32 known and publicized tourist facility or attraction.

33       (12) A personnel discipline action, or materials or documents supporting that action.

34       (13) Fish and wildlife information developed pursuant to ORS 496.004, 496.172 and 498.026 or  
35 ORS 496.192 and 564.100, regarding the habitat, location or population of any threatened species or  
36 endangered species.

37       (14) Writings prepared by or under the direction of faculty of public educational institutions, in  
38 connection with research, until publicly released, copyrighted or patented.

39       (15) Computer programs developed or purchased by or for any public body for its own use. As  
40 used in this subsection, "computer program" means a series of instructions or statements which  
41 permit the functioning of a computer system in a manner designed to provide storage, retrieval and  
42 manipulation of data from such computer system, and any associated documentation and source  
43 material that explain how to operate the computer program. "Computer program" does not include:

44       (a) The original data, including but not limited to numbers, text, voice, graphics and images;

45       (b) Analyses, compilations and other manipulated forms of the original data produced by use of

1 the program; or

2 (c) The mathematical and statistical formulas which would be used if the manipulated forms of

3 the original data were to be produced manually.

4 (16) Data and information provided by participants to mediation under ORS 36.256.

5 (17) Investigatory information relating to any complaint or charge filed under ORS chapter 654,

6 until a final administrative determination is made or, if a citation is issued, until an employer re-

7 ceives notice of any citation.

8 (18) Specific operational plans in connection with an anticipated threat to individual or public

9 safety for deployment and use of personnel and equipment, prepared or used by a public body, if

10 public disclosure of the plans would endanger an individual's life or physical safety or jeopardize a

11 law enforcement activity.

12 (19)(a) Audits or audit reports required of a telecommunications carrier. As used in this para-

13 graph, "audit or audit report" means any external or internal audit or audit report pertaining to a

14 telecommunications carrier, as defined in ORS 133.721, or pertaining to a corporation having an af-

15 filiated interest, as defined in ORS 759.390, with a telecommunications carrier that is intended to

16 make the operations of the entity more efficient, accurate or compliant with applicable rules, pro-

17 cedures or standards, that may include self-criticism and that has been filed by the telecommuni-

18 cations carrier or affiliate under compulsion of state law. "Audit or audit report" does not mean an

19 audit of a cost study that would be discoverable in a contested case proceeding and that is not

20 subject to a protective order; and

21 (b) Financial statements. As used in this paragraph, "financial statement" means a financial

22 statement of a nonregulated corporation having an affiliated interest, as defined in ORS 759.390,

23 with a telecommunications carrier, as defined in ORS 133.721.

24 (20) The residence address of an elector if authorized under ORS 247.965 and subject to ORS

25 247.967.

26 (21) The following records, communications and information submitted to a housing authority

27 as defined in ORS 456.005, or to an urban renewal agency as defined in ORS 457.010, by applicants

28 for and recipients of loans, grants and tax credits:

29 (a) Personal and corporate financial statements and information, including tax returns;

30 (b) Credit reports;

31 (c) Project appraisals, excluding appraisals obtained in the course of transactions involving an

32 interest in real estate that is acquired, leased, rented, exchanged, transferred or otherwise disposed

33 of as part of the project, but only after the transactions have closed and are concluded;

34 (d) Market studies and analyses;

35 (e) Articles of incorporation, partnership agreements and operating agreements;

36 (f) Commitment letters;

37 (g) Project pro forma statements;

38 (h) Project cost certifications and cost data;

39 (i) Audits;

40 (j) Project tenant correspondence requested to be confidential;

41 (k) Tenant files relating to certification; and

42 (L) Housing assistance payment requests.

43 (22) Records or information that, if disclosed, would allow a person to:

44 (a) Gain unauthorized access to buildings or other property;

45 (b) Identify those areas of structural or operational vulnerability that would permit unlawful

1 disruption to, or interference with, services; or

2 (c) Disrupt, interfere with or gain unauthorized access to public funds or to information pro-  
3 cessing, communication or telecommunication systems, including the information contained in the  
4 systems, that are used or operated by a public body.

5 (23) Records or information that would reveal or otherwise identify security measures, or  
6 weaknesses or potential weaknesses in security measures, taken or recommended to be taken to  
7 protect:

8 (a) An individual;

9 (b) Buildings or other property;

10 (c) Information processing, communication or telecommunication systems, including the infor-  
11 mation contained in the systems; or

12 (d) Those operations of the Oregon State Lottery the security of which are subject to study and  
13 evaluation under ORS 461.180 (6).

14 (24) Personal information held by or under the direction of officials of the Oregon Health and  
15 Science University or a public university listed in ORS 352.002 about a person who has or who is  
16 interested in donating money or property to the Oregon Health and Science University or a public  
17 university, if the information is related to the family of the person, personal assets of the person or  
18 is incidental information not related to the donation.

19 (25) The home address, professional address and telephone number of a person who has or who  
20 is interested in donating money or property to a public university listed in ORS 352.002.

21 (26) Records of the name and address of a person who files a report with or pays an assessment  
22 to a commodity commission established under ORS 576.051 to 576.455, the Oregon Beef Council  
23 created under ORS 577.210 or the Oregon Wheat Commission created under ORS 578.030.

24 (27) Information provided to, obtained by or used by a public body to authorize, originate, re-  
25 ceive or authenticate a transfer of funds, including but not limited to a credit card number, payment  
26 card expiration date, password, financial institution account number and financial institution routing  
27 number.

28 (28) Social Security numbers as provided in ORS 107.840.

29 (29) The electronic mail address of a student who attends a public university listed in ORS  
30 352.002 or Oregon Health and Science University.

31 (30) The name, home address, professional address or location of a person that is engaged in,  
32 or that provides goods or services for, medical research at Oregon Health and Science University  
33 that is conducted using animals other than rodents. This subsection does not apply to Oregon Health

19 **SECTION 17. Applicability.** The amendments to ORS 33.420 and 33.460 by sections 11 and  
20 12 of this 2026 Act apply to an application for change of name, application for legal change  
21 of sex or application for simultaneous change of name and legal change of sex that is filed  
22 with the court on or after July 1, 2026, and, upon motion of the applicant, to an application  
23 for legal change of sex or application for simultaneous change of name and legal change of  
24 sex that was filed with the court before July 1, 2026.

25 **SECTION 18. Delayed operative date.** (1) The amendments to ORS 33.420 and 33.460 by  
26 sections 11 and 12 of this 2026 Act become operative on July 1, 2026.

27 (2) The Judicial Department may take any action before the operative date specified in  
28 subsection (1) of this section that is necessary to enable the department to exercise, on and
