PROPOSED MINORITY REPORT AMENDMENTS TO SENATE BILL 1507

1 On page 1 of the printed bill, line 2, after “amending” delete the rest of
2 the line and insert “ORS 178.300, 178.375, 238A.005, 238A.125, 238A.150,
3 238A.170, 238A.230, 238A.370, 238A.400, 238A.410, 238A.415, 238A.430,
4 238A.435, 305.239, 305.494, 305.690, 305.842, 314.011, 314.306, 315.004, 315.266,
5 316.012, 316.147, 316.157, 317.010, 317.097, 317A.100, 458.670, 657.010 and
6 657B.010;”.

7 Delete lines 5 through 27 and delete pages 2 through 5 and insert:

8 **“SECTION 1.** ORS 178.300 is amended to read:

9 “178.300. As used in ORS 178.300 to 178.360:

10 “(1) ‘Account’ means an individual account established in accordance with
11 ORS 178.300 to 178.360.

12 “(2) ‘Account owner’ means the person who has the right to withdraw
13 funds from the account. The account owner may also be the designated ben-
14 eficiary of the account.

15 “(3) ‘Board’ means the Oregon 529 Savings Board established under ORS
16 178.310.

17 “(4) ‘Designated beneficiary’ means, except as provided in ORS 178.350,
18 the individual designated at the time the account is opened as having the
19 right to receive a qualified withdrawal for the payment of qualified higher
20 education expenses, or if the designated beneficiary is replaced in accordance
21 with ORS 178.350, the replacement.

1 “(5) ‘Financial institution’ means a bank, a commercial bank, a national
2 bank, a savings bank, a savings and loan, a thrift institution, a credit union,
3 an insurance company, a trust company, a mutual fund, an investment firm
4 or other similar entity authorized to do business in this state.

5 “(6) ‘Higher education institution’ means an eligible education institution
6 as defined in section 529(e)(5) of the Internal Revenue Code.

7 “(7) ‘Internal Revenue Code’ means the federal Internal Revenue Code as
8 amended and in effect on December 31, [2023] **2025**.

9 “(8) ‘Member of the family’ shall have the same meaning as contained in
10 section 529(e) of the Internal Revenue Code.

11 “(9) ‘Network’ means the Oregon 529 Savings Network established under
12 ORS 178.305.

13 “(10) ‘Nonqualified withdrawal’ means a withdrawal from an account that
14 is not a qualified withdrawal.

15 “(11) ‘Qualified higher education expenses’ means tuition and other per-
16 mitted expenses as set forth in section 529(e) of the Internal Revenue Code
17 for the enrollment or attendance of a designated beneficiary at a higher ed-
18 ucation institution, expenses associated with registered apprenticeship pro-
19 grams described in section 529(c)(8) of the Internal Revenue Code and
20 amounts paid as principal or interest on a qualified education loan to the
21 extent allowed under section 529(c)(9) of the Internal Revenue Code.

22 “(12) ‘Qualified withdrawal’ means a withdrawal made as prescribed under
23 ORS 178.355 and made:

24 “(a) From an account to pay the qualified higher education expenses of
25 the designated beneficiary;

26 “(b) As the result of the death or disability of the designated beneficiary;

27 “(c) As the result of a scholarship, allowance or payment described in
28 section 135(d)(1)(A), (B) or (C) of the Internal Revenue Code that is received
29 by the designated beneficiary, but only to the extent of the amount of the
30 scholarship, allowance or payment; or

1 “(d) As a rollover or change in the designated beneficiary described in
2 ORS 178.350.

3 **“SECTION 2.** ORS 178.375 is amended to read:

4 “178.375. As used in this section and ORS 178.380 and 178.385:

5 “(1) ‘ABLE account’ means an account established by an eligible individ-
6 ual, owned by the eligible individual and maintained under the qualified
7 ABLE program established by the Oregon 529 Savings Board under ORS
8 178.380.

9 “(2) ‘ABLE Act’ means the Stephen Beck, Jr., Achieving a Better Life
10 Experience Act of 2014 (Division B of P.L. 113-295).

11 “(3) ‘Designated beneficiary’ has the same meaning as contained in sec-
12 tion 529A of the Internal Revenue Code.

13 “(4) ‘Eligible individual’ has the same meaning as contained in section
14 529A of the Internal Revenue Code.

15 “(5) ‘Internal Revenue Code’ means the federal Internal Revenue Code as

29 ticipating public employer, including persons considered employees of a par-

17 tively participating in an optional retirement plan offered under ORS 243.815;

18 “(i) Persons employed in positions classified as post-doctoral scholar po-
19 sitions by a public university listed in ORS 352.002, or by the Oregon Health
20 and Science University, under ORS 350.370;

21 “(j) Any employee who belongs to a class of employees that was not eli-
22 gible on August 28, 2003, for membership in the system under the provisions
23 of ORS chapter 238 or other law;

24 “(k) Any person who belongs to a class of employees who are not eligible
25 to become members of the Oregon Public Service Retirement Plan under the
26 provisions of ORS 238A.070 (2);

27 “(L) Any person who is retired under ORS 238A.100 to 238A.250 or ORS
28 chapter 238 and who continues to receive retirement benefits while employed;
29 and

30 “(m) Judges.

1 “(5) ‘Firefighter’ means:

2 “(a) A person employed by a local government, as defined in ORS 174.116,
3 whose primary job duties include the fighting of fires;

4 “(b) The State Fire Marshal, chief deputy state fire marshals and deputy
5 state fire marshals;

6 “(c) An employee of the State Fire Marshal whose primary duties include
7 fire investigation, fire prevention, fire safety, fire control or fire suppression;

8 “(d) An employee of the State Forestry Department who is certified by the
9 State Forester as a professional wildland firefighter and whose primary du-
10 ties include the abatement of uncontrolled fires as described in ORS 477.064;
11 and

12 “(e) An employee of the Oregon Military Department whose primary du-
13 ties include fighting structural, aircraft, wildland or other fires.

14 “(6) ‘Fund’ means the Public Employees Retirement Fund.

15 “(7)(a) ‘Hour of service’ means:

16 “(A) An hour for which an eligible employee is directly or indirectly paid
17 or entitled to payment by a participating public employer for performance
18 of duties in a qualifying position; and

19 “(B) An hour of vacation, holiday, illness, incapacity, jury duty, military
20 duty or authorized leave during which an employee does not perform duties
21 but for which the employee is directly or indirectly paid or entitled to pay-
22 ment by a participating public employer for services in a qualifying position,
23 as long as the hour is within the number of hours regularly scheduled for
24 the performance of duties during the period of vacation, holiday, ill-
25 capacity, jury duty, military duty or authorized leave.

2 who is not employed in a qualifying position.

5 lished under ORS 238A.025.

6 “(10) ‘Institution of higher education’ means a public university listed in
7 ORS 352.002, the Oregon Health and Science University or a community
8 college, as defined in ORS 341.005.

9 “(11) ‘Member’ means an eligible employee who has established member-
10 ship in the pension program or the individual account program of the Oregon
11 Public Service Retirement Plan and whose membership has not been termi-
12 nated under ORS 238A.110 or 238A.310.

13 “(12) ‘Participating public employer’ means a public employer as defined
14 in ORS 238.005 that provides retirement benefits for employees of the public
15 employer under the system.

16 “(13) ‘Pension program’ means the defined benefit pension program of the
17 Oregon Public Service Retirement Plan established under ORS 238A.025.

18 “(14) ‘Police officer’ means a police officer as described in ORS 238.005.

19 “(15) ‘Qualifying position’ means one or more jobs with one or more par-
20 ticipating public employers in which an eligible employee performs 600 or
21 more hours of service in a full calendar year, or would perform 600 or more
22 hours of service if the employee were employed for the full calendar year,
23 excluding any service in a job for which benefits are not provided under the
24 Oregon Public Service Retirement Plan pursuant to ORS 238A.070 (2).

25 “(16) ‘Retired member’ means a pension program member who is receiving
26 a pension as provided in ORS 238A.180 to 238A.195.

27 “(17)(a) ‘Salary’ means the remuneration paid to an active member in re-
28 turn for services to the participating public employer, including
29 remuneration in the form of living quarters, board or other items of value,
30 to the extent the remuneration is, or would be if the member were an Oregon

1 resident, includable in the employee's taxable income under Oregon law.
2 'Salary' includes the additional amounts specified in paragraph (b) of this
3 subsection, but does not include the amounts specified in paragraph (c) of
4 this subsection, regardless of whether those amounts are includable in tax-
5 ble income.

6 “(b) 'Salary' includes the following amounts:

7 “(A) Payments of employee and employer money into a deferred compen-
8 sation plan that are made at the election of the employee.

9 “(B) Contributions to a tax-sheltered or deferred annuity that are made
10 at the election of the employee.

11 “(C) Any amount that is contributed to a cafeteria plan or qualified
12 transportation fringe benefit plan by the employer at the election of the
13 employee and that is not includable in the taxable income of the employee
14 by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on December 31, [2023]
15 **2025.**

16 “(D) Any amount that is contributed to a cash or deferred arrangement
17 by the employer at the election of the employee and that is not included in
18 the taxable income of the employee by reason of 26 U.S.C. 402(e)(3), as in
19 effect on December 31, [2023] **2025.**

20 “(E) Retroactive payments described in ORS 238.008.

21 “(F) The amount of an employee contribution to the individual account
22 program that is paid by the employer and deducted from the compensation
23 of the employee, as provided under ORS 238A.335 (1) and (2)(a).

24 “(G) The amount of an employee contribution to the individual account
25 program that is not paid by the employer under ORS 238A.335.

26 “(H) Wages of a deceased member paid to a surviving spouse or dependent
27 children under ORS 652.190.

28 “(c) 'Salary' does not include the following amounts:

29 “(A) Travel or any other expenses incidental to employer's business which
30 is reimbursed by the employer.

1 “(B) Payments made on account of an employee’s death.

2 “(C) Any lump sum payment for accumulated unused sick leave, vacation
3 leave or other paid leave.

4 “(D) Any severance payment, accelerated payment of an employment
5 contract for a future period or advance against future wages.

6 “(E) Any retirement incentive, retirement bonus or retirement gratuitous
7 payment.

8 “(F) Payment for a leave of absence after the date the employer and em-
9 ployee have agreed that no future services in a qualifying position will be
10 performed.

11 “(G) Payments for instructional services rendered to public universities
12 listed in ORS 352.002 or the Oregon Health and Science University when
13 those services are in excess of full-time employment subject to this chapter.
14 A person employed under a contract for less than 12 months is subject to this
15 subparagraph only for the months covered by the contract.

16 “(H) The amount of an employee contribution to the individual account
17 program that is paid by the employer and is not deducted from the compen-
18 sation of the employee, as provided under ORS 238A.335 (1) and (2)(b).

19 “(I) Compensation described and authorized under ORS 341.556 that is not
20 paid by the community college employing the faculty member.

21 “(J) Compensation described and authorized under ORS 352.232 that is not
22 paid by the public university employing the officer or employee.

23 “(K) Compensation described and authorized under ORS 353.270 that is
24 not paid by Oregon Health and Science University.

25 “(L) For years before 2020, any amount in excess of \$200,000 for a calen-
26 dar year. If any period over which salary is determined is less than 12
27 months, the \$200,000 limitation for that period shall be multiplied by a frac-
28 tion, the numerator of which is the number of months in the determination
29 period and the denominator of which is 12. The board shall adopt rules ad-
30 justing this dollar limit to incorporate cost-of-living adjustments authorized

1 by the Internal Revenue Service.

2 “(M) For years beginning on or after January 1, 2020, any amount in ex-
3 cess of \$195,000 for a calendar year. If any period over which salary is de-
4 termined is less than 12 months, the \$195,000 limitation for that period shall
5 be multiplied by a fraction, the numerator of which is the number of months
6 in the determination period and the denominator of which is 12. On January
7 1 of each year, the board shall adjust the dollar limit provided by this sub-
8 paragraph to reflect any percentage changes in the Consumer Price Index for
9 All Urban Consumers, West Region (All Items), as published by the Bureau

28 der paragraph (b) of this subsection, add nonapportionable income allocable
29 entirely to Oregon under ORS 314.280 or 314.625 to 314.645, or subtract
30 nonapportionable loss allocable entirely to Oregon under ORS 314.280 or

1 314.625 to 314.645. The resulting figure is ‘taxable income or loss’ for those
2 corporations carrying on taxable transactions or activities both within and
3 without Oregon.

4 “(11) As used in ORS 317.650 to 317.665, ‘insurer’ means any domestic,
5 foreign or alien insurer as defined in ORS 731.082 and any interinsurance
6 and reciprocal exchange and its attorney in fact with respect to its attorney
7 in fact net income as a corporate attorney in fact acting as attorney in
8 compliance with ORS 731.458, 731.462, 731.466 and 731.470 for the reciprocal
9 or interinsurance exchange. However, ‘insurer’ does not include title insurers
10 or health care service contractors operating pursuant to ORS 750.005 to
11 750.095.

12 **“SECTION 27.** ORS 317.097 is amended to read:

13 “317.097. (1) As used in this section:

14 “(a) ‘Annual rate’ means the yearly interest rate specified on the note,
15 and not the annual percentage rate, if any, disclosed to the applicant to
16 comply with the federal Truth in Lending Act.

17 “(b) ‘Bonds’ means a bond, as defined in ORS 286A.001, if issued on behalf
18 of the Housing and Community Services Department, or bonds, as defined in
19 ORS 456.055, if issued by a housing authority.

20 “(c) ‘Finance charge’ means the total of all interest, loan fees, interest
21 on any loan fees financed by the lending institution, and other charges re-
22 lated to the cost of obtaining credit.

23 “(d) ‘Lending institution’ means any insured institution, as that term is
24 defined in ORS 706.008, any mortgage banking company that maintains an
25 office in this state or any community development corporation that is or-
26 ganized under the Oregon Nonprofit Corporation Law.

27 “(e) ‘Limited equity cooperative’ means a cooperative corporation formed
28 under ORS chapter 62 whose articles of incorporation, in addition to the
29 other requirements of ORS chapter 62, prohibit members from selling their
30 ownership interests:

1 “(A) To any person other than a low income person; or
2 “(B) For a sales price that exceeds the sum of:
3 “(i) The price the member paid for the ownership interest;
4 “(ii) The cost of any permanent improvements the member made to the
5 housing unit during the member’s ownership;
6 “(iii) Any special assessments the member paid to the limited equity co-
7 operative during the member’s ownership that were expended to make per-
8 manent improvements to the building in which the member’s housing unit is
9 located; and
10 “(iv) A return on the amounts described in sub-subparagraphs (i) to (iii)
11 of this subparagraph, computed from the year in which the respective amount
12 was paid, that equals the greater of the result of adjusting each amount by
13 the percentage increase, if any, in the Consumer Price Index for All Urban
14 Consumers, West Region (All Items), as published by the Bureau of Labor
15 Statistics of the United States Department of Labor, or of increasing each
16 amount by three percent compounded annually.

17 “(f) ‘Manufactured dwelling park’ has the meaning given that term in
18 ORS 446.003.

19 “(g) ‘Nonprofit corporation’ means a corporation that is exempt from in-
20 come taxes under section 501(c)(3) or (4) of the Internal Revenue Code as
21 amended and in effect on December 31, [2023] **2025**.

22 “(h) ‘Preservation project’ means housing that was previously developed
23 as affordable housing with a contract for rent assistance from the United
24 States Department of Housing and Urban Development or the United States
25 Department of Agriculture and that is being acquired by a sponsoring entity.

26 “(i) ‘Qualified assignee’ means any investor participating in the secondary
27 market for real estate loans.

28 “(j) ‘Qualified borrower’ means any borrower that is a sponsoring entity
29 that has a controlling interest in the real property that is financed by a
30 qualified loan. A controlling interest includes a controlling interest in the

1 general partner of a limited partnership that owns the real property.

2 “(k) ‘Qualified loan’ means:

3 “(A) A loan that meets the criteria stated in subsection (5) of this section
4 or that is made to refinance a loan that meets the criteria described in sub-
5 section (5) of this section;

6 “(B) The purchase by a lending institution of bonds, the proceeds of which
7 are used to finance or refinance a loan that meets the criteria described in
8 subsection (5) of this section; or

9 “(C) A qualified mortgage loan fund.

10 “(L) ‘Qualified mortgage loan fund’ means a fund that:

11 “(A) Is operated by a lending institution described in subsection (12) of
12 this section;

13 “(B) Makes mortgages to first-time home buyers;

14 “(C) Makes mortgages for homes subject to a land trust mortgage; and

15 “(D) Makes mortgages to households that, at the time of mortgage origi-
16 nation, have income that is 80 percent or less of area median income as de-
17 fined in ORS 458.610.

18 “(m) ‘Sponsoring entity’ means a nonprofit corporation, nonprofit cooper-
19 ative, state governmental entity, local unit of government as defined in ORS
20 466.706, housing authority or any other person, provided that the person has
21 agreed to restrictive covenants imposed by a nonprofit corporation, nonprofit
22 cooperative, state governmental entity, local unit of government or housing
23 authority.

24 “(2) The Department of Revenue shall allow a credit against taxes other-
25 wise due under this chapter for the tax year to a lending institution that
26 makes a qualified loan certified by the Housing and Community Services
27 Department as provided in subsection (7) of this section. The amount of the
28 credit is equal to the difference between:

29 “(a) The amount of finance charge charged by the lending institution
30 during the tax year at an annual rate less than the market rate for a quali-

1 fied loan that complies with the requirements of this section; and

2 “(b) The amount of finance charge that would have been charged during
3 the tax year by the lending institution for the qualified loan for housing
4 construction, development, acquisition or rehabilitation measured at the an-
5 nual rate charged by the lending institution for nonsubsidized loans made
6 under like terms and conditions at the time the qualified loan for housing
7 construction, development, acquisition or rehabilitation is made.

8 “(3) The maximum amount of credit for the difference between the
9 amounts described in subsection (2)(a) and (b) of this section may not exceed
10 four percent of the average unpaid balance of the qualified loan during the
11 tax year for which the credit is claimed.

12 “(4) Any tax credit allowed under this section that is not used by the
13 taxpayer in a particular year may be carried forward and offset against the
14 taxpayer's tax liability for the next succeeding tax year. Any credit remain-
15 ing unused in the next succeeding tax year may be carried forward and used
16 in the second succeeding tax year, and likewise, any credit not used in that
17 second succeeding tax year may be carried forward and used in the third
18 succeeding tax year, and any credit not used in that third succeeding tax
19 year may be carried forward and used in the fourth succeeding tax year, and
20 any credit not used in that fourth succeeding tax year may be carried for-
21 ward and used in the fifth succeeding tax year, but may not be carried for-
22 ward for any tax year thereafter.

23 “(5) To be eligible for the tax credit allowable under this section, a
24 lending institution must make a qualified loan by either purchasing bonds,
25 the proceeds of which are used to finance or refinance a loan that meets the
26 criteria stated in this subsection, or making a loan directly to:

27 “(a) An individual or individuals who own a dwelling, participate in an
28 owner-occupied community rehabilitation program and are certified by the
29 local government or its designated agent as having an income level when the
30 loan is made of 80 percent of the area median income or less;

1 “(b) A qualified borrower who:

2 “(A) Uses the loan proceeds to finance construction, development, acqui-
3 sition or rehabilitation of housing, including housing in the form of a limited
4 equity cooperative; and

5 “(B) Provides a written certification executed by the Housing and Com-
6 munity Services Department that the:

7 “(i) Housing created by the loan is or will be occupied by households
8 earning 80 percent of the area median income or less; and

9 “(ii) Full amount of savings from the reduced interest rate provided by
10 the lending institution is or will be passed on, in the form of reduced housing
11 payments, to the tenants or to the holders of proprietary leases in a limited
12 equity cooperative;

13 “(c) Subject to subsection (14) of this section, a qualified borrower who:

14 “(A) Uses the loan proceeds to finance construction, development, acqui-
15 sition or rehabilitation of housing consisting of a manufactured dwelling
16 park; and

17 “(B) Provides a written certification executed by the Housing and Com-
18 munity Services Department that the housing will continue to be operated
19 as a manufactured dwelling park during the period for which the tax credit
20 is allowed;

21 “(d) A qualified borrower who:

22 “(A) Uses the loan proceeds to finance acquisition or rehabilitation of
23 housing consisting of a preservation project; and

24 “(B) Provides a written certification executed by the Housing and Com-
25 munity Services Department that the housing preserved by the loan:

26 “(i) Is or will be occupied by households earning 80 percent of the area
27 median income or less; and

28 “(ii) Is the subject of a rent assistance contract with the United States
29 Department of Housing and Urban Development or the United States De-
30 partment of Agriculture that will be maintained by the qualified borrower;

1 “(e) A qualified borrower who:

2 “(A) Uses the loan proceeds to finance construction, development, acqui-
3 sition or rehabilitation of housing; and

4 “(B) Provides a written certification executed by the Housing and Com-
5 munity Services Department or the governmental party to the rent assistance
6 contract that the housing preserved by the loan:

7 “(i) Is or will be occupied by households earning 80 percent of the area
8 median income or less; and

9 “(ii) Is the subject of a rent assistance contract with the federal govern-
10 ment or with a state or local government that will be maintained by the
11 qualified borrower and that limits a tenant’s rent to no more than 30 percent
12 of their income;

13 “(f) A qualified borrower who:

14 “(A) Uses the loan proceeds to finance preservation or rehabilitation of
15 housing; and

16 “(B) Provides a written certification executed by the Housing and Com-
17 munity Services Department that the housing preserved or rehabilitated by
18 the loan:

19 “(i) Is or will be occupied by households earning 80 percent of the area
20 median income or less; and

21 “(ii) Is currently characterized by financial or physical distress that
22 threatens its ongoing viability as an affordable housing resource; or

23 “(g) A qualified mortgage loan fund.

24 “(6) A loan made to refinance a loan that meets the criteria stated in
25 subsection (5) of this section must be treated the same as a loan that meets
26 the criteria stated in subsection (5) of this section.

27 “(7) For a qualified loan to be eligible for the tax credit allowable under
28 this section, the Housing and Community Services Department must execute
29 a written certification for the qualified loan that:

30 “(a) States that the qualified loan is within the limitation imposed by

1 subsection (8) of this section; and

2 “(b) Specifies the period, as determined by the Housing and Community
3 Services Department, during which the tax credit is allowed for the qualified
4 loan, not to exceed:

5 “(A) 30 years, for a qualified loan with a contract for rent assistance or
6 financing resources from the United States Department of Agriculture, for
7 new housing construction, acquisition of housing or a preservation project;
8 or

9 “(B) 20 years, for any other type of qualified loan.

10 “(8) The Housing and Community Services Department may certify qualifi-
11 fied loans that are eligible under subsection (5) of this section if the total
12 credits attributable to all qualified loans eligible for credits under this sec-
13 tion and then outstanding do not exceed \$35 million for any fiscal year. In
14 making loan certifications under subsection (7) of this section, the Housing
15 and Community Services Department shall attempt to distribute the tax
16 credits statewide, but shall concentrate the tax credits in those areas of the
17 state that are determined by the Oregon Housing Stability Council to have
18 the greatest need for affordable housing.

19 “(9) The tax credit provided for in this section may be taken whether or
20 not:

21 “(a) The financial institution is eligible to take a federal income tax
22 credit under section 42 of the Internal Revenue Code with respect to the
23 project financed by the qualified loan;

24 “(b) The project receives financing from bonds, the interest on which is
25 exempt from federal taxation under section 103 of the Internal Revenue Code;
26 or

27 “(c) The project receives moneys from the Elderly and Disabled Housing
28 Fund under ORS 456.535.

29 “(10) For a qualified loan defined in subsection (1)(k)(B) of this section
30 financed through the purchase of bonds, the interest of which is exempt from

1 federal taxation under section 103 of the Internal Revenue Code, the amount
2 of finance charge that would have been charged under subsection (2)(b) of
3 this section is determined by reference to the finance charge that would have
4 been charged if the federally tax exempt bonds had been issued and the tax
5 credit under this section did not apply.

6 “(11) A lending institution may sell a qualified loan for which a certi-
7 fication has been executed to a qualified assignee whether or not the lending
8 institution retains servicing of the qualified loan so long as a designated
9 lending institution maintains records, annually verified by a loan servicer,
10 that establish the amount of tax credit earned by the taxpayer throughout
11 each year of eligibility.

12 “(12) Notwithstanding any other provision of law, a lending institution
13 that is a community development corporation organized under the Oregon
14 Nonprofit Corporation Law may transfer all or part of a tax credit allowed
15 under this section to one or more other lending institutions that are stock-
16 holders or members of the community development corporation or that oth-
17 erwise participate through the community development corporation in the
18 making of one or more qualified loans for which the tax credit under this
19 section is allowed.

20 “(13) The lending institution shall file an annual statement with the
21 Housing and Community Services Department, specifying that it has con-
22 formed with all requirements imposed by law to qualify for a tax credit under

25 borrower on a loan to finance the construction, development, acquisition or
26 rehabilitation of a manufactured dwelling park under subsection (5)(c) of this
27 section must be:

28 “(a) A nonprofit corporation, manufactured dwelling park nonprofit co-
29 operative, state governmental entity, local unit of government as defined in
30 ORS 466.706 or housing authority; or

1 “(b) A nonprofit corporation or housing authority that has a controlling
2 interest in the real property that is financed by a qualified loan. A control-
3 ling interest includes a controlling interest in the general partner of a lim-
4 ited partnership that owns the real property.

5 “(15) The Department of Revenue may require that a lending institution
6 that has earned the credit and a lending institution that intends to claim the
7 credit jointly file a notice, as prescribed by the Department of Revenue. The
8 notice must comply with ORS 315.056 (2) or 315.058 (2).

9 “(16) The Housing and Community Services Department shall provide in-
10 formation to the Department of Revenue about all certifications executed
11 under this section, if required by ORS 315.058.

12 “(17) The Housing and Community Services Department and the Depart-
13 ment of Revenue may adopt rules to carry out the provisions of this section.

14 **“SECTION 28.** ORS 317A.100, as amended by section 6, chapter 502,
15 Oregon Laws 2025, is amended to read:

16 “317A.100. As used in ORS 317A.100 to 317A.158:

17 “(1)(a) ‘Commercial activity’ means:

18 “(A) The total amount realized by a person, arising from transactions and
19 activity in the regular course of the person’s trade or business, without de-
20 duction for expenses incurred by the trade or business;

21 “(B) If received by a financial institution:

22 “(i) If the reporting person for a financial institution is a holding com-
23 pany, all items of income reported on the FR Y-9 filed by the holding com-
24 pany;

25 “(ii) If the reporting person for a financial institution is a bank organ-
26 ization, all items of income reported on the call report filed by the bank or-
27 ganization; and

28 “(iii) If the reporting person for a financial institution is a nonbank fi-
29 nancial organization, all items of income reported in accordance with gen-
30 erally accepted accounting principles; and

1 “(C)(i) If received by an insurer, as reported on the statement of premiums
2 accompanying the annual statement required under ORS 731.574 to be filed
3 with the Director of the Department of Consumer and Business Services, all
4 gross direct life insurance premiums, gross direct accident and health insur-
5 ance premiums and gross direct property and casualty insurance premiums;
6 and

7 “(ii) The gross amount of surplus lines premiums received on Oregon
8 home state risks as shown in the report required by ORS 735.465.

9 “(b) ‘Commercial activity’ does not include:

10 “(A) Interest income except:

11 “(i) Interest on credit sales; or

12 “(ii) Interest income, including service charges, received by financial in-
13 stitutions;

14 “(B) Receipts from the sale, exchange or other disposition of an asset
15 described in section 1221 or 1231 of the Internal Revenue Code, without re-
16 gard to the length of time the person held the asset;

17 “(C) If received by an insurer, federally reinsured premiums or income
18 from transactions between a reciprocal insurer and its attorney in fact op-
19 erating under ORS 731.142;

20 “(D) Receipts from hedging transactions, to the extent that the trans-
21 actions are entered into primarily to protect a financial position, including
22 transactions intended to manage the risk of exposure to foreign currency
23 fluctuations that affect assets, liabilities, profits, losses, equity or invest-
24 ments in foreign operations, risk of exposure to interest rate fluctuations or
25 risk of commodity price fluctuations;

26 “(E) Proceeds received attributable to the repayment, maturity or re-
27 demption of the principal of a loan, bond, mutual fund, certificate of deposit
28 or marketable instrument;

29 “(F) The principal amount received under a repurchase agreement or on
30 account of any transaction properly characterized as a loan to the person;

1 “(G) Contributions received by a trust, plan or other arrangement, any
2 of which is described in section 501(a) of the Internal Revenue Code, or to
3 which title 26, subtitle A, chapter 1, subchapter (D) of the Internal Revenue
4 Code applies;

5 “(H) Compensation, whether current or deferred, and whether in cash or
6 in kind, received or to be received by an employee, a former employee or the
7 employee's legal successor for services rendered to or for an employer, in-
8 cluding reimbursements received by or for an individual for medical or edu-
9 cation expenses, health insurance premiums or employee expenses or on
10 account of a dependent care spending account, legal services plan, any cafe-
11 teria plan described in section 125 of the Internal Revenue Code or any
12 similar employee reimbursement;

13 “(I) Proceeds received from the issuance of the taxpayer's own stock,
14 options, warrants, puts or calls, or from the sale of the taxpayer's treasury
15 stock;

16 “(J) Proceeds received on the account of payments from insurance poli-
17 cies, including crop insurance policies, owned by the taxpayer, except those
18 proceeds received for the loss of commercial activity;

19 “(K) Gifts or charitable contributions received, membership dues received
20 by trade, professional, homeowners' or condominium associations, payments
21 received for educational courses, meetings or meals, or similar payments to
22 a trade, professional or other similar association, and fundraising receipts
23 received by any person when any excess receipts are donated or used exclu-
24 sively for charitable purposes;

25 “(L) Damages received as the result of litigation in excess of amounts
26 that, if received without litigation, would be treated as commercial activity;

27 “(M) Property, money and other amounts received or acquired by an agent
28 on behalf of another in excess of the agent's commission, fee or other
29 remuneration;

30 “(N) Tax refunds from any tax program, other tax benefit recoveries and

1 reimbursements for the tax imposed under ORS 317A.100 to 317A.158 made
2 by entities that are part of the same unitary group as provided under ORS
3 317A.106, and reimbursements made by entities that are not members of a
4 unitary group that are required to be made for economic parity among mul-
5 tiple owners of an entity whose tax obligation under ORS 317A.100 to
6 317A.158 is required to be reported and paid entirely by one owner, as pro-
7 vided in ORS 317A.106;

8 “(O) Pension reversions;

9 “(P) Contributions to capital;

10 “(Q) Receipts from the sale, transfer, exchange or other disposition of
11 motor vehicle fuel or any other product used for the propulsion of motor
12 vehicles;

13 “(R) In the case of receipts from the sale of cigarettes or tobacco products
14 by a wholesale dealer, retail dealer, distributor, manufacturer or seller, an
15 amount equal to the federal and state excise taxes paid by any person on or
16 for such cigarettes or tobacco products under subtitle E of the Internal
17 Revenue Code or ORS chapter 323;

18 “(S) In the case of receipts from the sale of malt beverages or wine, as
19 defined in ORS 471.001, cider, as defined in ORS 471.023 or distilled liquor,
20 as defined in ORS 471.001, by a person holding a license issued under ORS
21 chapter 471, an amount equal to the federal and state excise taxes paid by
22 any person on or for such malt beverages, wine or distilled liquor under
23 subtitle E of the Internal Revenue Code or ORS chapter 471 or 473, and any
24 amount paid to the Oregon Liquor and Cannabis Commission for sales of
25 distilled spirits by an agent appointed under ORS 471.750;

26 “(T) In the case of receipts from the sale of marijuana items, as defined
27 in ORS 475C.009, by a person holding a license issued under ORS 475C.005
28 to 475C.525, an amount equal to the federal and state excise taxes paid by
29 any person on or for such marijuana items under subtitle E of the Internal
30 Revenue Code or ORS 475C.670 to 475C.734 and any local retail taxes au-

1 thorized under ORS 475C.453;

2 "(U) Local taxes collected by a restaurant or other food establishment on
3 sales of meals, prepared food or beverages;

4 "(V) Tips or gratuities collected by a restaurant or other food establish-
5 ment and passed on to employees;

6 "(W) Receipts realized by a vehicle dealer certified under ORS 822.020 or
7 a person described in ORS 320.400 (8)(a)(B) from the sale or other transfer
8 of a motor vehicle, as defined in ORS 801.360, to another vehicle dealer for
9 the purpose of resale by the transferee vehicle dealer, but only if the sale
10 or other transfer was based upon the transferee's need to meet a specific
11 customer's preference for a motor vehicle or is an exchange of new vehicles
12 between franchised motor vehicle dealerships;

13 "(X) Registration fees or taxes collected by a vehicle dealer certified un-
14 der ORS 822.020 or a person described in ORS 320.400 (8)(a)(B) at the sale
15 or other transfer of a motor vehicle, as defined in ORS 801.360, that are owed
16 to a third party by the purchaser of the motor vehicle and passed to the third
17 party by the dealer;

18 "(Y) Receipts from a financial institution for services provided to the fi-
19 nancial institution in connection with the issuance, processing, servicing and
20 management of loans or credit accounts, if the financial institution and the
21 recipient of the receipts have at least 50 percent of their ownership interests
22 owned or controlled, directly or constructively through related interests, by
23 common owners;

24 "(Z) In the case of amounts retained as commissions by a holder of a li-
25 cense under ORS chapter 462, an amount equal to the amounts specified un-
26 der ORS chapter 462 that must be paid to or collected by the Department of
27 Revenue as a tax and the amounts specified under ORS chapter 462 to be
28 used as purse money;

29 "(AA) Receipts of residential care facilities as defined in ORS 443.400 or
30 in-home care agencies as defined in ORS 443.305, to the extent that the re-

1 ceipts are derived from or received as compensation for providing services
2 to a medical assistance or Medicare recipient;

3 “(BB) Dividends received;

4 “(CC) Distributive income received from a pass-through entity;

5 “(DD) Receipts from sales to a wholesaler in this state, if the seller re-
6 ceives certification at the time of sale from the wholesaler that the whole-
7 saler will sell the purchased property outside this state;

8 “(EE) Receipts from the wholesale or retail sale of groceries, including
9 receipts of a person that owns groceries at the time of sale and compensation
10 of any consignee engaged in effecting the sale of groceries on behalf the
11 owner of the groceries, but only to the extent that the compensation relates
12 to grocery sales;

13 “(FF) Receipts from transactions among members of a unitary group;

14 “(GG) Moneys, including public purpose charge moneys collected under
15 ORS 757.612 and moneys collected to plan for and pursue cost-effective en-
16 ergy efficiency resources under ORS 757.054, that are collected from cus-
17 tomers, passed to a utility and approved by the Public Utility Commission
18 and that support energy conservation, renewable resource acquisition and
19 low-income assistance programs;

20 “(HH) Moneys collected by a utility from customers for the payment of
21 loans through on-bill financing;

22 “(II) Surcharges collected under ORS 757.736;

23 “(JJ) Moneys passed to a utility by the Bonneville Power Administration
24 for the purpose of effectuating the Regional Power Act Exchange credits or
25 pursuant to any settlement associated with the exchange credit;

26 “(KK) Moneys collected or recovered, by entities listed in ORS 756.310,
27 cable operators as defined in 47 U.S.C. 522(5), telecommunications carriers
28 as defined in 47 U.S.C. 153(51) and providers of information services as de-
29 fined in 47 U.S.C. 153(24), for fees payable under ORS 756.310, right-of-way
30 fees, franchise fees, privilege taxes, federal taxes and local taxes;

1 “(LL) Charges assessed under ORS 759.685 and paid into the Residential
2 Service Protection Fund;

3 “(MM) Universal service surcharge moneys collected or recovered and
4 paid into the universal service fund established in ORS 759.425;

5 “(NN) Moneys collected for public purpose funding as described in ORS
6 759.430;

7 “(OO) Moneys collected or recovered and paid into the federal universal
8 service fund as determined by the Federal Communications Commission;

9 “(PP) In the case of a seller or provider of telecommunications services,
10 the amount of tax imposed under ORS 403.200 for access to the emergency
11 communications system that is collected from subscribers or consumers;

12 “(QQ) In the case of a transient lodging tax collector, the amount of tax
13 imposed under ORS 320.305 and of any local transient lodging tax imposed
14 upon the occupancy of transit lodging;

15 “(RR) In the case of a seller of bicycles, the amount of tax imposed under

26 “(14) ‘Person’ includes individuals, combinations of individuals of any
27 form, receivers, assignees, trustees in bankruptcy, firms, companies, joint-

29 partnerships, limited liability companies, associations, joint ventures, clubs,
30 societies, entities organized as for-profit corporations under ORS chapter 60,

1 C corporations, S corporations, qualified subchapter S subsidiaries, qualified
2 subchapter S trusts, trusts, entities that are disregarded for federal income
3 tax purposes and any other entities.

4 “(15) ‘Retailer’ means a person doing business by selling tangible personal
5 property to a purchaser for a purpose other than:

6 “(a) Resale by the purchaser of the property as tangible personal property
7 in the regular course of business;

9 ular business as an ingredient or component of real or personal property; or

17 “(b) ‘Taxpayer’ does not include excluded persons, except to the extent

19 Internal Revenue Code.

20 “(18) ‘Tax year’ means, except as otherwise provided in ORS 317A.103, a
21 taxpayer’s annual accounting period used for federal income tax purposes
22 under section 441 of the Internal Revenue Code.

23 “(19)(a) ‘Unitary business’ means a business enterprise in which there
24 exists directly or indirectly between the members or parts of the enterprise
25 a sharing or exchange of value as demonstrated by:

26 “(A) Centralized management or a common executive force;

1 “(b) ‘Unitary business’ may include a business enterprise the activities

10 tivities that constitute a unitary business.

7 lockout in which wages, hours, working conditions or terms of employment
8 of the individuals are involved.

9 “(16) ‘Lockout’ means any refusal by an employer to permit employees to
10 work as a result of a dispute with the employees affecting wages, hours or
11 other terms or conditions of their employment.

12 “(17) ‘Nonprofit employing unit’ means an organization, or group of org-
13 anizations, described in section 501(c)(3) of the Internal Revenue Code that
14 is exempt from income tax under section 501(a) of the Internal Revenue Code.

7 authority or public corporation, or any instrumentality of a county, city,

20 “(6) If the amount allowable as a credit under this section, when added
21 to the sum of the amounts allowable as payment of tax under ORS 316.187
22 or 316.583, other tax prepayment amounts and other refundable credit
23 amounts, exceeds the taxes imposed by ORS chapters 314 and 316 for the tax
24 year after application of any nonrefundable credits allowable for purposes
25 of ORS chapter 316 for the tax year, the amount of the excess shall be re-
26 funded to the taxpayer as provided in ORS 316.502.

27 “(7) The Department of Revenue may adopt rules for purposes of this
28 section, including but not limited to rules relating to proof of eligibility, the
29 furnishing of information regarding the federal earned income credit claimed
30 by the taxpayer for the tax year and policies and guidelines for the deter-

1 mination of the amount of credit allowed under subsection (2) of this section.

2 “(8) Refunds attributable to the earned income credit allowed under this
3 section do not bear interest.

4 **“SECTION 35. The amendments to ORS 315.266 by section 34 of this**
5 **2026 Act apply to tax years beginning on or after January 1, 2026.**

6 **“SECTION 36. This 2026 Act takes effect on the 91st day after the**
7 **date on which the 2026 regular session of the Eighty-third Legislative**
8 **Assembly adjourns sine die.”.**
