**PROPOSED AMENDMENTS TO
SENATE BILL 1580**

1 On page 1 of the printed bill, delete lines 3 through 18 and delete page
2 2.
3 On page 3, delete lines 1 through 3.
4 Delete lines 25 through 42 and insert:
5 “(5)(a) ‘Covered platform’ means a business that:
6 “(A) Operates one or more online platforms;
7 “(B) Accesses online content;
8 “(C) Aggregates, distributes, renders or displays online content that the
9 covered platform accesses;
10 “(D) Earns more than 25 percent of its annual revenue from advertising
11 services; and
12 “(E) At any point during the last 12-month period:
13 “(i) Had at least 50 million monthly active users or subscribers in the
14 United States across the covered platform’s online platforms; and
15 “(ii) Had or is owned or controlled by a parent corporation with:
16 “(I) Annual revenues or a market capitalization in the United States that
17 is greater than \$550 billion, adjusted annually for inflation since 2026 based
18 on the Consumer Price Index for All Urban Consumers, West Region (All
19 Items), as published by the Bureau of Labor Statistics of the United States
20 Department of Labor; or
21 “(II) At least one billion worldwide monthly active users across the cov-

1 ered platform's or parent corporation's online platforms.

2 “(b) ‘Covered platform’ does not include:

3 “(A) A business that earns at least 40 percent of its annual revenue, as
4 calculated at the level of the ultimate corporate parent, from the sale of
5 goods or cloud services.

6 “(B) A business that operates as its primary business a social media
7 platform.”.

8 On page 5, after line 12, insert:

9 “(13) ‘Social media platform’ means an Internet-based service or applica-
10 tion that:

11 “(a) Permits a person to become a user of the service or application:

12 “(A) By registering as a user, establishing an account or creating a pro-
13 file; and

14 “(B) For the purpose of allowing the user to create, share and view
15 user-generated content;

16 “(b) Allows one or more users to generate content that can be viewed by
17 other users; and

18 “(c) Primarily serves as a medium for users to interact with content
19 generated by other users.”.

20 In line 13, delete “(13)” and insert “(14)”.

21 On page 6, delete lines 33 through 45.

22 On page 7, delete lines 1 through 26 and insert:

23 **“NOTE:** Section 4 was deleted by amendment. Subsequent sections were
24 not renumbered.”.

25 On page 12, line 25, delete “70” and insert “90”.

26 In line 27, before the period insert “for the primary purpose of producing
27 content for an Oregon audience”.

28 On page 16, delete lines 31 and 32.

29 In line 33, delete “(3)” and insert “(2)”.
