**PROPOSED AMENDMENTS TO
HOUSE BILL 4009**

1 On page 1 of the printed bill, line 2, after “319.885” delete the rest of the
2 line.

3 In line 3, delete “319.920, 319.925, 319.930”.

4 Delete lines 6 through 22 and delete pages 2 through 4.

5 On page 5, delete lines 1 through 30 and insert:

9 of 90 days or less.]

12 vehicle fuel, as defined in ORS 319.010, to power an internal combustion en-
13 gine or other source of propulsion;]

14 “[B] Is equipped with an onboard charger; and]

15 “[C] Is rechargeable from a connection to an external electric power
16 source.]

17 “[b] The Department of Transportation may adopt rules that clarify the
18 definition in paragraph (a) of this subsection to account for changes in the
19 technology or nomenclature of plug-in hybrid electric vehicles.]

29 state that is required to obtain a vehicle dealer certificate under ORS

2 Oregon Laws 2025 (special session), and section 1 of this 2026 Act, is
3 amended to read:

21 **“(B) A new electric vehicle;**

22 **“(c) For reporting periods beginning on or after July 1, 2028:**

23 **“(A) A motor vehicle described in paragraph (a) or (b) of this sub-**
24 **section; or**

25 **“(B) Any hybrid electric vehicle or a new plug-in hybrid electric**
26 **vehicle; or**

27 **“(d) For reporting periods beginning before July 1, 2031:**

28 **“(A) A motor vehicle described in paragraph (a), (b) or (c) of this**
29 **subsection; or**

30 **“(B) The subject of an application approved pursuant to ORS**

2 “[7] (11) ‘Vehicle dealer’ means a person engaged in business in this
3 state that is required to obtain a vehicle dealer certificate under ORS
4 822.005.

5 **“SECTION 3. The amendments to ORS 319.883 by section 2 of this**
6 **2026 Act become operative on July 1, 2027.**

7 **“SECTION 4.** ORS 319.883, as amended by sections 30 and 32, chapter 1,
8 Oregon Laws 2025 (special session), and sections 1 and 2 of this 2026 Act, is
9 amended to read:

10 “319.883. As used in ORS 319.883 to 319.946:

20 “*[(A) A motor vehicle described in paragraph (a) of this subsection; or]*

21 “*[(B) A new electric vehicle;]*

22 “*[(c) For reporting periods beginning on or after July 1, 2028:]*

23 “*[(A) A motor vehicle described in paragraph (a) or (b) of this subsection;*
24 *or]*

25 “*[(B)] (b) [Any] A hybrid electric vehicle or [a new] plug-in hybrid elec-*
26 *tric vehicle.[: or]*

27 “*[(d) For reporting periods beginning before July 1, 2031:]*

28 “*[(A) A motor vehicle described in paragraph (a), (b) or (c) of this sub-*
29 *section; or]*

30 “*[(B) The subject of an application approved pursuant to ORS 319.890.]*

1 “(11) ‘Vehicle dealer’ means a person engaged in business in this state
2 that is required to obtain a vehicle dealer certificate under ORS 822.005.”.
