**PROPOSED AMENDMENTS TO  
SENATE BILL 1570**

1        In line 2 of the printed bill, after “facilities” insert “; and prescribing an  
2        effective date”.

3        Delete lines 4 through 8 and insert:

4        **“SECTION 1. (1) As used in this section:**

5        **“(a) ‘Hospital’ has the meaning given that term in ORS 442.015.**

6        **“(b) ‘Individually identifiable health information’ has the meaning  
7        given that term in ORS 192.556.**

8        **“(c) ‘Information concerning a person’s citizenship or immigration  
9        status’ has the meaning given that term in ORS 180.805.**

10       **“(d) ‘Law enforcement authority’ includes a federal, state and local  
11       law enforcement authority.**

12       **“(2) A hospital shall designate which areas of the hospital are not  
13       open to the public. Areas designated as not open to the public must  
14       include any area:**

15       **“(a) Where entry or access to the area is controlled; or**

16       **“(b) That is a patient room.**

17       **“(3) A hospital may not disclose for the purpose of law enforcement  
18       individually identifiable health information or information concerning  
19       a person’s citizenship or immigration status unless disclosure is:**

20       **“(a) Required by state or federal law or an order of a court of  
21       competent jurisdiction, including a judicial warrant; or**

1       **“(b) For the purpose of ensuring continuity of care.**

2       **“(4) A hospital shall adopt and maintain written policies and pro-**  
3 **cedures that:**

4       **“(a) Address how the hospital will respond if a law enforcement**  
5 **authority arrives at the hospital; and**

6       **“(b) Identify for the hospital at least one administrator in a super-**  
7 **visory role who is designated to respond when a law enforcement au-**  
8 **thority arrives at the hospital.**

9       **“SECTION 2. (1) As used in this section, ‘health care facility’**  
10 **means:**

11       **“(a) A hospital as defined in ORS 442.015.**

12       **“(b) A federally qualified health center as defined in 42 U.S.C.**  
13 **1396d(l)(2).**

14       **“(2) It is an unlawful employment practice for a health care facility**  
15 **to retaliate or take disciplinary action against an employee of the**  
16 **health care facility because the employee has distributed informational**  
17 **or educational materials concerning immigrant rights and available**  
18 **immigration legal services if the materials are published or otherwise**  
19 **made available by a state agency.**

20       **“(3) An employee who alleges a violation of this section may file a**  
21 **complaint with the Commissioner of the Bureau of Labor and Indus-**  
22 **tries in the manner provided by ORS 659A.820.**

23       **“(4) Nothing in this section prohibits a collective bargaining agree-**  
24 **ment from establishing terms that are more protective than the re-**  
25 **quirements under this section.**

26       **“SECTION 3. Section 4 of this 2026 Act is added to and made a part**  
27 **of ORS 192.553 to 192.581.**

28       **“SECTION 4. (1) As used in this section:**

29       **“(a) ‘Health care facility’ means:**

30       **“(A) A hospital as defined in ORS 442.015.**

1       **“(B) A federally qualified health center as defined in 42 U.S.C.**  
2       **1396d(l)(2).**

3       **“(b) ‘Information concerning a person’s citizenship or immigration**  
4       **status’ has the meaning given that term in ORS 180.805.**

5       **“(2) A health care provider that is a health care facility shall treat**  
6       **information concerning a person’s citizenship or immigration status**  
7       **or a person’s country of birth in the same manner that the health care**  
8       **provider is required to treat protected health information under state**  
9       **law.**

10       **“SECTION 5. This 2026 Act takes effect on the 91st day after the**  
11       **date on which the 2026 regular session of the Eighty-third Legislative**  
12       **Assembly adjourns sine die.”.**
