

# **Oregon Publishers and Broadcasters Support the Oregon Journalism Protection Act (SB 1580)**

February 2026

Oregon's news economy is no longer a fair marketplace. It has become a one-way extraction system in which the largest, international technology platforms take the value of local reporting while returning almost nothing to the newsrooms that create it or the communities who rely on it. SB 1580 is the corrective action required to restore fairness, accountability, and stability to an information ecosystem that has been distorted for far too long.

**Mega-platforms are profiting from exploiting local Oregon businesses.** Local outlets invest in journalists, editors, photographers, fact-checkers, and the infrastructure required to create original reporting that serves their communities. Meanwhile, mega-platforms use that reporting to create AI news summaries and drive up their traffic without paying for the work that makes their products valuable. SB 1580 rebalances this relationship. It ensures that the economic value created in Oregon stays in Oregon, giving publishers the stability to hire, innovate, and rebuild the local news capacity our state has lost.

**Big Tech is essentially a “plagiarism machine” that is exploiting journalists’ work without compensation.** Journalism is labor. It is the daily work of gathering facts, verifying information, and holding institutions accountable. When platforms profit from that labor without compensating it, jobs disappear and communities lose their watchdogs. SB 1580 ensures that compensation flows directly to newsroom staff. It protects existing jobs, creates the conditions for new ones, and affirms that Oregon values the workers who keep the public informed.

**When newsrooms close, Oregonians lose.** Local news is part of the infrastructure that holds our communities together. When it erodes, civic participation declines, misinformation spreads, and public trust weakens. SB 1580 reinvests in this critical infrastructure. It strengthens small and rural outlets, nonprofit newsrooms, multilingual publications, and emerging community media so that every Oregonian has access to credible, independent information.

**We, the undersigned Oregon news publishers and broadcasters, urge you to support SB 1580. Oregon cannot afford to let its information ecosystem continue to be drained by global mega technology platforms. This legislation is a fair, necessary, and forward-looking step toward restoring the conditions in which local journalism – and democracy – can thrive.**
