Chair Gelser Blouin and Members of the Committee,

Oregon CASA Network (OCN) is pleased to offer our testimony in support of Senate Bill 1533 with the -1 amendments, which aims to expand and reinforce the rights of children in foster care and their siblings. As a statewide nonprofit organization, OCN works tirelessly to provide training, technical support, and legal assistance to 19 local CASA programs spanning all 36 counties in Oregon. Through CASA's efforts, thousands of dedicated volunteers advocate for the wellbeing of children and youth in foster care, both in the courtroom and their daily lives.

We stand behind SB 1533 due to its critical enhancements to the Oregon Foster Children's Bill of Rights and the Oregon Foster Children's Sibling Bill of Rights. These changes have the potential to improve the quality of life for one of the most vulnerable demographics – children and youth who have faced abuse and neglect.

SB 1533 ensures that children in foster care have consistent and unimpeded access to adults who serve as advocates for their needs, and that their voice in court is clear. Beyond the enhancement to their rights, this means that children and youth can have a heightened sense of emotional safety.

SB 1533 is a crucial step in safeguarding the dignity of children and youth in foster care by granting them access to belongings of personal significance, providing comfort and connection during transitions. Additionally, the bill preserves their inherent dignity by codifying the appropriate transport of personal belongings.

SB 1533 recognizes the significance of meaningful connections by ensuring foster youth maintain vital relationships with siblings – relationships that require nurturing and support. By prioritizing regular sibling interaction, this bill upholds the emotional needs of children in foster care and offers them much-needed stability. Additionally, SB 1533 grants access to crucial information about siblings, which demonstrates respect and dignity for the involved youth.
