### **Re: Support for Capital Funding - Safe, Clean, and Healthy Salem Initiative**

Esteemed Co-Chairs and Members of the Subcommittee,

On behalf of Salem Firefighters Local 314, I write in strong support of the City of Salem's 2025-27 Capital Funding Request submitted to the Joint Committee on Ways & Means Capital Construction Subcommittee for the Safe, Clean, and Healthy Salem initiative.

As first responders serving Oregon's capital city, Salem firefighters witness daily the complex public safety challenges present in and around the Capitol Mall. The concentration of essential state government facilities, community service providers, businesses, and vulnerable populations creates a unique operational environment requiring coordinated, sustained investment. From the fire service perspective, the need addressed in this project is not theoretical, it directly impacts emergency call volume, responder safety, and long-term community risk reduction.

Encampments and unmanaged public spaces often present elevated fire risk from open flames, propane heating sources, and improvised electrical systems. They also generate increased emergency medical responses related to overdose, untreated mental illness, chronic disease complications, and crisis-driven behavior. These incidents place strain on fire and EMS resources and create safety concerns for both responders and the public accessing Capitol-area facilities.

The Safe, Clean, and Healthy Salem initiative—along with the expansion of the Homeless Services Team (HST) and complementary outreach efforts such as the REACH pilot program—represents a proactive and coordinated response model. By focusing on outreach, service connection, and stabilization rather than enforcement alone, these programs reduce repeat 9-1-1 calls, improve interagency coordination, and help prevent crises from escalating into fire or medical emergencies.

Investment through capital construction and related public safety funding mechanisms ensures that the necessary infrastructure, staffing capacity, and program support are in place to sustain this coordinated model. Ensuring safety, cleanliness, and accessibility around the Capitol Mall is not solely a local concern, it is a statewide interest affecting legislators, state employees, visitors, and residents from across Oregon.
