

HB4018 -6 and -8 Back Room "Support"

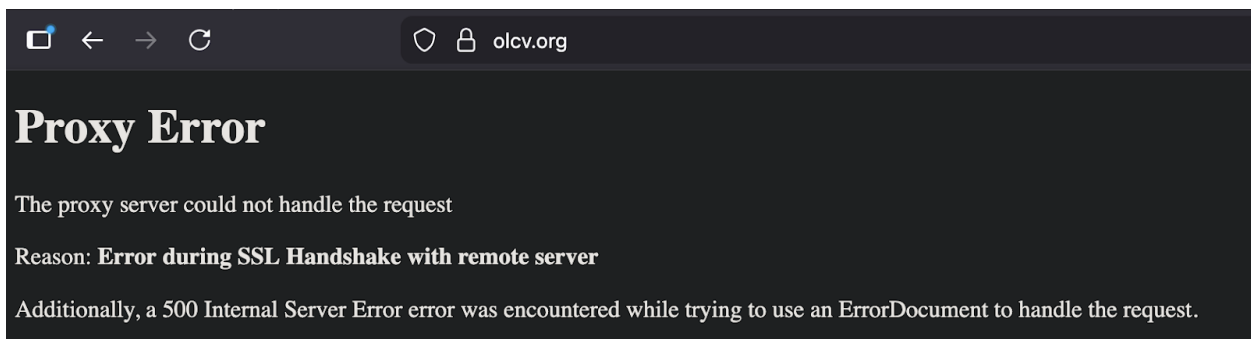
I'm Seth Woolley, Treasurer of the Pacific Green Party, and we're actively communicating with our members about the threat the 2026 HB4018 gut and stuff amendments are to real campaign finance reform without gigantic loopholes that render the hard won reforms we worked on moot. We helped collect over 100,000 signatures for IP-9 that lead to 2024 HB4024.

Groups like **Oregon League of Conservation Voters (OLCV)**, **Oregon Education Association (OEA)**, and **Our Oregon** are grossly misleading their followers by saying that the proposed huge amendments (84 pages and 95 pages) to HB4024 somehow serve the purpose of campaign finance reform. The exact opposite is true. Those amendments would destroy the campaign contribution limits and disclosure requirements enacted by the Oregon Legislature in 2024 as a compromise with Honest Elections Oregon (which includes Pacific Green Party).

I am also subscribed to OLCV's alerts and get their emails, which during this short session come frequently. Britney VanCitters and Eliza Walton are sending email blasts regularly. Attached are two examples around the time period of this effort by Britney to claim in testimony here:

My name is Britney VanCitters, and I'm the Political & Organizing Director at the Oregon League of Conservation Voters (OLCV). OLCV works to protect Oregon's clean air, water, natural spaces, wildlife, and communities by engaging throughout the political process. A healthy, fair, and accessible democracy is essential to fulfilling our mission to protect Oregon's people and places. **I'm writing on behalf of OLCV and our over 7,200 active members across Oregon** to urge you to support HB 4018 with the -6 amendment.

But **they have been utterly silent on this bill** over the last month. I also tried to check their website, but the site of these **experts on IT system complexity** we are to trust looks like this:



A couple hours later the site was working again and mentions only 3 priorities, none involving this (see attached).

The Pacific Green Party has sent emails and posted to our site.

My wife is also a **member of OEA** and expressed disappointment about her organization being listed as a sponsor of these measures. She has also **not received any communications** about what they are doing. At the end of this week she received a summary email that **goes also to a non-working website** (see attached timeout page – a refresh did show it eventually) though the email can still be read (three pages attached). It also doesn't mention this bill at all despite going into detail on pretty much everything else they did this week.

Finally, in the communication from Our Oregon, sent two hours after the draft showed up, also attached, they announce it as a way to protect campaign finance reform, **when it does the exact opposite.** They basically plead for more money and “technical fixes” and say literally nothing about the details.

Could it be that none of these “supporters” want their members to be aware of either their position on these amendments or the truth of what the amendments do?

Take Action: Stop the 1,700 acre land grab!

Hi Seth,

The 2026 short session is underway, and we're already seeing a dangerous Major Threat ([SB 1586](#)) to long-standing agreements and Oregon's land use laws.

SB 1586 would open up 1,700 acres of world-class farmland, by expanding the Metro urban growth boundary into land protected as rural reserves and zoned exclusively for farm use. This land was explicitly safeguarded through a 2014 legislative settlement that every stakeholder agreed to honor known as the [grand bargain](#). In this exchange, Hillsboro received over 1,000 acres of farmland for industrial use. This bill breaks that promise and opens the door to another speculative land grab. Once this farmland is gone, it's gone forever. And it's not needed: Oregon already has thousands of acres of industrial land inside cities, including in Hillsboro.

This bill has not been scheduled for a public hearing yet. [Please send your message to your legislators today to stop this Major Threat!](#)

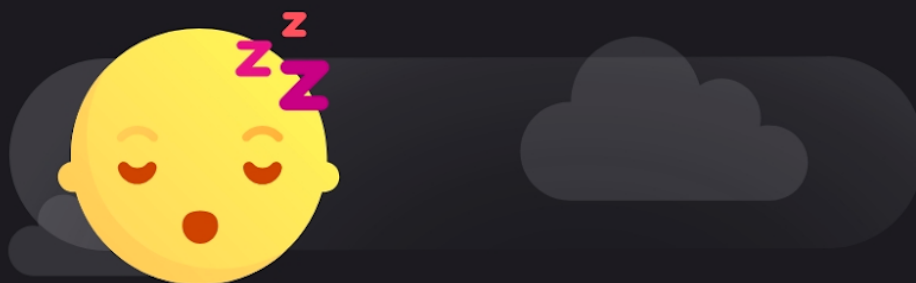

Three Easy Ways to Engage

Take Action Today! Oregon's 35-day legislative session is going fast and the voices of OEA members are needed.

Here are 3 ways you can take action today to help make a concrete difference:

1. The **Immigrant Justice Package** that the Oregon Education Association prioritized as a part of our federal response work to support students and keep communities safe **NEEDS YOUR HELP**. The legislative deadlines are coming close and the package and a number of bills need help to keep moving. **Tell Lawmakers to Support Immigrant Justice!**
2. **Take Action at the Capitol on Presidents' Day**. Join us in sending a clear message to legislators that we expect them to stop giving tax cuts to the ultra -rich and to instead fund our schools and communities in a way that enables us all to thrive. **RSVP and join us!**
3. **Sign up for rapid response updates and commit to take legislative action**. We need members who can quickly make phone calls in the coming days, or come to Salem to pack a hearing room. This is our opportunity to ensure legislators feel the real public accountability to disconnect from the federal tax cuts that benefit corporations and the wealthy and prioritize preventing cuts to schools, healthcare and food assistance.
 - a. We expect a vote on this next Monday – join us and watch the debate in the Senate Chamber on Presidents' day around 11am at the Oregon State Capitol.
 - b. After this top priority passes the Senate, there may be a hearing as soon as Wednesday and we will put an alert out for help

What happened this week in Salem?

OEA opposed SB 1555 which would have abolished the Quality Education Commission and the current approach to the Quality Education Model that is the process in Oregon for determining adequate funding of Education. After two weeks of work Senator Frederick announced Thursday morning that the bill would not be moving forward. OEA staff caught this bill when it was filed, OEA members reached out with concern, and we all worked to ensure legislators knew this was a drastic change with no process to determine what is best. OEA member leaders working hard on HB 4011-1: Bargaining Rights Restoration Bill

On behalf of the OEA, President Enrique Farrera testified before the House Labor and Workforce Committee in support of HB 4011-1, which would make class size and caseload a mandatory subject of bargaining.

OEA brought seven witnesses to the table. Each one spoke from expertise or direct experience, and together they neutralized opposition arguments before they gained traction.

Greater Albany Education Association President Dana Lovejoy told the committee what educators in Albany went through when their school district ignored class size during negotiations. Albany educators fought back through a strike to make sure students and teachers were not forgotten at the bargaining table.

Salem Keizer Education Association Vice-President Tyler Scialo-Lakeberg shared how their bargaining team was able to negotiate class size early in the process, showing the committee that this work is possible when both sides come prepared.

The result: legislators have told us directly that our testimony changed the narrative around this bill in a positive and productive way. OEA's preparation and the strength of our member leaders made the difference.
