### Support for HB 4136

Dear Chair Nathanson, Vice-Chairs Reschke and Walters, and Members of the Committee:

House Bill 4136 secures reliable funding for Oregon's successful downpayment assistance program, making homeownership a reality for thousands of Oregon families who are ready to set down roots in communities all across our state. These are households that can afford the monthly expense of a mortgage, but remain locked out of homeownership by the high cost of a downpayment. The Oregon Housing Alliance asks you to support HB 4136. This legislation overcomes the downpayment barrier with one-time assistance that sets families up for decades of stable, affordable housing.

HB 4136 will provide funds to help some 250 low- and moderate-income families each year to purchase their first home – without requiring any new spending. The dedicated revenue for this program comes from redirecting existing spending away from an antiquated, counterproductive subsidy in our state's tax code: the mortgage interest deduction for vacation properties. A bonus tax break for vacation houses – in addition to the deduction that homeowners will continue to be able to claim for the mortgages on their actual homes – is a poor use of our state's resources. This tax deduction does not promote homeownership; it undermines it. By offering the MID for vacation properties, the state helps pay for houses that are largely vacant and remain off the market for homebuyers – further limiting supply and driving up prices. Vacation properties are a wonderful privilege for some, but they should not receive a state subsidy. Those resources should instead support Oregonians who are working and saving to purchase their *first* homes.

Supporting first-time homebuyers in place of an extra subsidy for those who own multiple personal properties is a wise decision, and a fair decision. The Oregon Housing Alliance calls on you to invest in the future of your constituents and our communities across the state, by securing a reliable pathway to homeownership through HB 4136.
